

# October 10, 2017 Orange Park Library

#### I. Call to Order:

Jon Guthrie called the meeting to order at 7:00pm.

#### II. Review of Minutes:

### III. Officer Reports:

- a. Vice President Jon Guthrie
  - Resigning of current president, Michelle McCullough: Michelle sent an email to the
    officers of the board indicating that she wished to resign both the position of
    presidency as well as her board of director position.
    - o Bylaws state that the vice-president is to fill the president position in the case of this event, which Jon has now done.
    - Michelle's resignation created an opening for both the vice-president as well as a board of director position. The motion to elect Dave Allen as vicepresident was made by Sara Guthrie and seconded by Kathy Murray. Unanimous decision was made and passed.
    - A motion was made, seconded and passed unanimously to elect Mike Mayse to fill the board of directors position.
  - RRCA Coaching Class scheduled for November 4<sup>th</sup> & 5<sup>th</sup>. The class is now full, and there is a waiting list. Jamie Williams and Vicky Connell are participating. Sara Guthrie and Jennifer DeSantis are providing food.
- b. Treasurer's Report Bill Krause via email
  - Request to reinvest the CDs which expire on November 15<sup>th</sup>
    - CDs were purchased 3 years ago for \$50,000 at a rate of just under 2%. Our balance is now \$59,536.26.
    - Recommending to add to the necessary balance from the main account on 11/15 to bring it up to \$60,000, and reinvest this into 3 more 5-year CDs (reasoning that 3 rather 1 CD would be a safeguard just in case the club had to redeem some of the money early).
    - o The amounts purchased were for \$10,000, \$10,000, and \$30,000.
    - Cheaper to pay a penalty for early withdrawal on \$10,000 than the entire \$50,000.

- Suggestion is to purchase CDs for \$15,000, \$15,000, and \$30,000.
- Motion was made by Shelly Allen to authorize Bill to round the moneys up to \$60,000 and seconded by George Hoskins. Unanimous decision was made and passed.

## **IV. Committee and Director Reports**:

- a. StrideRight Cari Holbrook
  - Deadline for the next issue is October 17<sup>th</sup>
- b. Social Dave Allen
  - Jennifer DeSantis requested that the November social take place at the Thanksgiving race (November 23<sup>rd</sup>) like last year. Details for that event will be posted to Facebook and placed in the StrideRight.
  - An informal social will take place at the cemetery following the Evergreen Pumpkin Run (October 29<sup>th</sup>). The yellow Strider tent will be set up in the parking lot area after the race.

# c. <u>Hog Jog Race Director – Bob Fernee</u>

- Race is scheduled for October 22<sup>nd</sup>, awards are on order, and t-shirts are ready. The company printing out the t-shirts are just waiting for the sponsor logos to put on the back.
- The Firewater Tent Revival band is lined up (different from last year) to play before and after the race, we'll have both our BBQ and Sonny's BBQ to feed everyone.
- Registrations are not that great right now they are up to 76 entries.
- We still need to make sure volunteer stations are covered.
- Suzanne Baker is heading the fun run which will take place at 2:00pm. The 5K will begin at 2:30.
